Cost of the Course: \$420.00 per student plus applicable tax \$30.00 = \$450.00

This includes thirty (30) hours of class (online or in person) using the curriculum “Responsible Driving” and seven (7) hours of Behind the Wheel driving. Also included are the MVD knowledge and skill exams, however the skills exam does not count toward the 7 hours of driving instruction time.

Refund Policy:

If the student withdraws at any time after the first day of class, a refund of up to \$250.00 will be allowed. Student must complete at least one hour of driving instruction within 30 days of the classroom completion. NMAC Rules and Regulations state student must complete the program within a year of enrollment. If the student misses any Behind the Wheel driving time, it will cost \$35.00 per hour for make up time.
